*Paint Out*

We want to take this opportunity to answer some of the questions we have received:

**Do the Artists have to participate each day?** Although we would love to have you participate each day, this is certainly up to each artist to decide for themselves. The artwork must be created on site in order to exhibit and be eligible for awards on Saturday, August 14.

**Are the Artists allowed to paint the Chattahoochee (and the Vickery Creek) area only or can they paint anything they wish to paint in Roswell?** The Chattahoochee River is the focus of the *Great Chattahoochee River Paint Out*. There will be designated sites from which you may choose to paint. At those sites during the day, we will have volunteers available to relieve the artists at specific times so they may go to lunch or take rest breaks. Artists may choose other locations along Riverside Road and the Don White Park area, if they wish, but we will not have volunteers available to assist at those sites. We encourage you to choose from the designated area. A map will be provided to you.

**Must artists paint the river as it flows through Roswell or may they choose other cities/areas through which the Chattahoochee flows?** You may only paint the Chattahoochee River in the designated areas and in Roswell.

**Will artists be allowed to paint the shoreline and buildings along the Chattahoochee if the river itself is not shown in the painting?** We leave this up to the artist to decide which Chattahoochee River image they would like to represent.

**What time will we be allowed to paint each day?** You will be allowed to paint from 8 A.M. to 8 P.M. However, at the Island Ford location the restrooms will only be available from 8 A.M. until 5 P.M. Please allow yourself time to leave the park prior to its closing for the evening. Each artist may decide what times they would like to paint.

**REGISTRATION & WELCOME RECEPTION:** There will be a registration and welcome reception at **7:30 P.M. on August 10<sup>th</sup>** at the host hotel, Holiday Inn – 909 Holcomb Bridge Road – Roswell, GA 30076 (770-817-1414). At the reception you will be given information packets as you register and answers to questions you may have on how to best utilize your time during the *Great Chattahoochee River Paint Out*. It is a time to celebrate the *Paint Out* and get to know those who are participating with you in the event. Casual attire; Refreshments served.

**Can I have someone pick up my information at registration, if I am unavailable?** Yes. If you can't be at registration on Tuesday evening, and you don't have someone available to pick it up for you, we will also have packets available at the hotel on Wednesday morning.

**Must we pay parking at the park locations that require a fee?** No, the Chattahoochee River National Recreation Area is providing free passes to their locations that require a fee; the other recommended locations do not have a fee to park.

**Transportation to Paint-Out Sites:** Artists providing their own transportation to the sites may paint at their discretion during the *Great Chattahoochee River Paint Out*. However, if you are from out-of-town and do not have a car available, we will try to assist you in getting to and from the hotel to your painting location. If you know that you will not have a vehicle available and do not have a friend who will be painting with you that has transportation, please let us know so that we can be prepared to assist.
